

WELLS COUNTY ORDINANCE NO. 2007-14

An Ordinance Creating a Project Lifesaver Donation/Operation Fund

WHEREAS, the Wells County Sheriff's office has requested the Wells County Board of Commissioners to create a Project Lifesaver Donations/Operation Fund; and

WHEREAS, the Wells County Sheriff proposes to solicit donations to this fund which are to be used to provide assistance to victims and caregivers of Alzheimer's and others who become lost because of physical or mental disorders; and


WHEREAS, the Wells County Sheriff's office proposes that the fund be used to provide radio transmitters and to purchase other equipment to assist caregivers and emergency personnel to locate lost individuals.


NOW, THEREFORE, BE IT ORDAINED by the Board of Commissioners of Wells County, Indiana, as follows:


1. A fund is hereby established under the Home Rule statute found at I.C. 36-1-3-1 et seq called the Project Lifesaver Donation/Operation Fund.
2. Such fund is to be created by solicited donations and is to be used under the supervision of the Wells County Sheriff.
3. The fund may be used to purchase equipment and other necessary items to help assist emergency personnel and caregivers to locate lost individuals who suffer from Alzheimer's and other physical and mental disabilities.
