

## Wells County Commissioners

### Regular Session 3-21-2011

The Wells County Commissioners met in regular session on Monday March 21, 2011 at 9AM in the Commissioner's Room of the Wells County Carnegie Annex, Bluffton, IN. Those in attendance were Commissioners, Kevin Woodward, Paul Bonham and C. Scott Mossburg. Also in attendance were County Attorney, Trent Patterson and County Auditor, Beth Davis.

**Minutes:** Motion made by Scott Mossburg, seconded by Paul Bonham to approve the minutes from March 7<sup>th</sup>, 2011 meeting. Motion carried 3-0.

**Payroll:** Commissioners approved Payroll #6 in the amount of \$191,697.03

**Claims:** Commissioners approved 215 claims in the amount of \$218,560.31

**Farm Lease:** Motion made by Scott Mossburg, seconded by Paul Bonham to allow Kevin to Sign amended rental agreement for county farm. Motion carried 3-0

**Wells County Sheriff:** Monte Fisher reported 85 inmates, 26 are DOC. November and December payments have been received.

**Re-Establishment of Property Lines:** Auditor, Beth Davis brought the board up to speed on what Michael, Tony and Jane have discussed, having Joel do a survey to determine how much of the properties are in each Township. Trent Patterson has received information from Larry Owen that he is still working on this issue. The board will table this issue until the next meeting on April 4<sup>th</sup>. Motion made by Scott Mossburg, seconded by Paul Bonham to table the re-establishment of property lines until all parties are in attendance. Motion carried 3-0.

**SCO Engineering:** Nathan Rumschlag introduced himself to the commissioners as a local civil engineer.

**Utility Permits:** Motion made by Scott Mossburg, seconded by Paul Bonham to table United REMC permit for County Road 450S until Larry Owen is present. Motion carried 3-0.

Motion made by Paul Bonham, seconded by Scott Mossburg to approve permits from Craigville Telephone Company for Hoosier Highway from Greenfield Farms Subdivision to CR 200S and along 200 S from approximately 150 feet west of Hoosier Highway easterly to CR 200 E. Motion carried 3-0.

Motion made by Paul Bonham, seconded by Scott Mossburg to approve permit from Craigville Telephone Company along CR 200E from CR 200S northerly to Farmington Drive. Motion carried 3-0.

**Agreement with City of Bluffton:** Motion made by Paul Bonham, seconded by Scott Mossburg to sign the agreement between City of Bluffton and County of Wells to have City of Bluffton reimburse County of Wells for ½ the cost for Cellebrite Universal Forensic Extraction Device. Motion carried 3-0.

**Washington/Main Commons Event Permit:** Motion made by Paul Bonham, seconded by Scott Mossburg to sign the permit for 1<sup>st</sup> Annual Steve Kelly Memorial Ride & Cruise 2011. Motion carried 3-0.

**Contract for Legal Services:** Motion made by Paul Bonham, seconded by Scott Mossburg to approve contract from Judge Kiracofe and Judge Goshorn to provide legal counsel for certain indigent persons and juveniles appearing before said courts. Motion carried 3-0. (Misc 2011-9)

**Petition to Appoint Director:** Motion made by Paul Bonham, seconded by Scott Mossburg to appoint Roger Irick as Director of the Rock Creek Conservancy District to a four year term expiring in January 2015. Motion carried 3-0.
