

Wells County Commissioners

Regular Session 10-17-2011

The Wells County Commissioners met in regular session on Monday October 17, 2011 at 9AM in the Commissioner's Room of the Wells County Carnegie Annex, Bluffton, IN. Those in attendance were Commissioners, Paul Bonham and C. Scott Mossburg. Also in attendance were County Attorney, Trent Patterson and County Auditor, Beth Davis. Commissioner Kevin Woodward was absent.

Minutes: Motion made by Scott Mossburg, seconded by Paul Bonham to approve the minutes from October 3, 2011 regular session. Motion carried 2-0.

Payroll: Commissioners approved Payroll #21 in the amount of \$188,560.68.

Claims: Commissioners approved 161 claims in the amount of \$225,056.00

Wells County Sheriff: Monte Fisher reported 90 inmates, 24 are DOC. Sheriff Fisher updated commissioners on the status for housing federal inmates.

Wells County Highway Supervisor: Ed Herman gave updates on MVH, LR&S and Wheel Tax. Ed provided a quote to update the Highway Radios to narrowband. Motion made by Scott Mossburg, seconded by Paul Bonham to approve the quote from Integrity Communications & Electronics Inc. in the amount of \$7145.00 to update Highway Radios to narrowband with part of the total paid in 2011 and the balance paid in 2012. Motion carried 2-0.

Emergency Meeting: An emergency meeting was called on October 4, 2011 to allow up to \$15,000.00 on work to be done to the culvert on Western Ave and the Johnson Drain. Motion made by Scott Mossburg, seconded by Paul Bonham to allow up to \$15,000.00 appropriation for the emergency action taken by the commissioners on October 4, 2011 regarding the Johnson Drain and Western Ave.

Zoning Ordinance Revisions: Motion made by Scott Mossburg, seconded by Paul Bonham to approve the Wells County Zoning Ordinance Revisions. Motion carried 2-0. Motion made by Scott Mossburg, seconded by Paul Bonham to allow Paul to sign the ordinance. First motion was withdrawn to allow for ordinance numbers. Motion made by Scott Mossburg, seconded by Paul Bonham to approve Zoning Ordinance Revisions (Ordinance number 2011-14). Motion carried 2-0. Motion made by Scott Mossburg, seconded by Paul Bonham to approve Subdivision Control Ordinance Revisions (Ordinance number 2011-15). Motion carried 2-0.

Sick Leave Bank Policy: Motion made by Scott Mossburg, seconded by Paul Bonham to approve the Sick Leave Bank Policy for Wells County (Misc 2011-19). Motion carried 2-0.
