WELLS COUNTY, INDIANA ORDINANCE NO. 2014- 2

ORDINANCE VACATING STREET

WHEREAS, on the 7th day of July, 2014, Dean A. Hirschy and Faith Hirschy, petitioned the Commissioners of Wells County, Indiana to vacate a portion of Maple Street located in the Town of Craigville, Wells County, Indiana and more particularly described as follows, to-wit:

Beginning at the northeast corner of Lot Numbered Six (6) as known and designated on the recorded Plat of Hartman's Second Addition to the Town of Craigville, Indiana; thence west 150 feet to the northwest corner of said Lot Numbered Six (6); thence north 50 feet to the southwest corner of Lot Numbered seven (7) as known and designated on the recorded Plat of Hartman's Second Addition to the Town of Craigville; thence east 150 feet to the southeast corner of said Lot Numbered Seven (7); thence south 50 feet to the place of beginning.

WHEREAS, after notice published according to law, the Commissioners of Wells County, Indiana held a public hearing concerning the Petition on the 7th day of July, 2014, and;

WHEREAS, all requirements of Indiana Law have been met;

NOW THEREFORE, be it ordained by the Commissioners of Wells County, Indiana, that:

1. The portion of Maple Street located in the Town of Craigville, Wells County, Indiana, and more particularly described as follows, to-wit:

Beginning at the northeast corner of Lot Numbered Six (6) as known and designated on the recorded Plat of Hartman's Second Addition to the Town of Craigville,

Indiana; thence west 150 feet to the northwest corner of said Lot Numbered Six (6); thence north 50 feet to the southwest corner of Lot Numbered seven (7) as known and designated on the recorded Plat of Hartman's Second Addition to the Town of Craigville; thence east 150 feet to the southeast corner of said Lot Numbered Seven (7); thence south 50 feet to the place of beginning.

is hereby vacated and that the adjoining property owners, Dean A. Hirschy and Faith Hirschy, husband and wife, shall receive ownership of the north one-half (1\2) of the real estate which abuts their real estate. The adjoining property owner, Richard D. Richardson, shall receive ownership of the south one-half (1\2) of the real estate which abuts his real estate.

2. This Ordinance shall be in full force and effect upon passage by the Commissioners of Wells County, Indiana.
