WELLS COUNTY COUNCIL ORDINANCE NO. 2015-12

A Wells County Council Ordinance Approving The Purchase Of A Blanket Bond or Crime Insurance Policy For Wells County Employees, Commission Members, And Any Persons Acting On Behalf Of Wells County Government

WHEREAS, Indiana Code 5-4-1-18 requires certain county officers and employees shall be covered by a surety bond or the fiscal body of the local government unit *may* authorize the purchase of a blanket bond or crime insurance policy endorsed to include faithful performance to cover the faithful performance of all employees, commission members, and persons acting on behalf of the local government unit; and

WHEREAS, the Wells County Commissioners have determined that there are long-term cost savings realized in purchasing a blanket bond or crime insurance policy endorsed to include faithful performance to cover the faithful performance of all employees, commission members, and any persons acting on behalf of Wells County Government; and

WHEREAS, the blanket bond or crime insurance policy coverage meets or exceeds the coverage requirements outlined in Indiana Code 5-4-1-18; and

WHEREAS, the blanket bond or crime insurance policy coverage remains in effect until determined otherwise by the Wells County Commissioners;

NOW, THEREFORE, BE IT ORDAINED by the Wells County Council:

1. The Wells County Council by ordinance authorizes the purchase of a blanket bond or a crime insurance policy endorsed to include faithful performance to cover the faithful performance of all employees, commission members, and any person acting on behalf of Wells County Government.
