This report provides a statistical breakdown of the volume and classification of criminal cases and charges, juvenile adjudications, and child support collection cases prosecuted and administered by the Wells County Prosecutor's Office in the year 2016. Below is a chart indicating the number of cases filed in each of the last 3 years. Please remember that multiple charges may be filed against one individual and that a case is be defined by the level of the most serious charge. These numbers do not include the numerous traffic infractions which come through the county criminal justice system.

Below is a chart which indicates the number of charges filed in 2016 for certain categories of offenses as compared to the same for 2015 and 2014.

The total number of cases filed increased more than 12% over 2015 and is up over 38% from 2014. Operating while intoxicated charges were down slightly from 2015, while thefts charges increased significantly from last year (although still down slightly from the year prior) The number of drug charges filed has continued to increase with the greatest increase in 2016 coming from the number of marijuana possession charges that we filed: 8 in 2014; 15 in 2015; and 28 in 2016 (all but one of which were misdemeanors).

The Child Support Division of the Wells County Prosecutor's Office collected \$2,892,458. The 2016 collection figures for Wells County were above the state performance averages, ranking Wells County 17<sup>th</sup> out of ninety-two (92) counties for current child support collected, and 30<sup>th</sup> out of ninety-two (92) counties for delinquent child support collected.
