Wells County Drainage Board Minutes Monday-May 6, 2019 8:30 A.M.

The Wells County Drainage Board met in a regular scheduled meeting at the Wells Carnegie Government Annex, 223W. Washington St., Multi-Purpose Room 105, (Lower Level), Bluffton, Indiana.

Drainage Board members present: Voting members Blake Gerber, Kevin Woodward, Tamara Robbins; Attorney Roy Johnson, Engineer Nate Rumschlag, Surveyor Jarrod Hahn, Secretary Diana Collins.

Determination of Quorum:

A quorum was present for the meeting.

Minutes:

Mr. Gerber opened the Drainage Board meeting with the first item on the agenda to approve the Board's regular meeting minutes on April 15, 2019.

Dr. Robbins motioned to approve the Drainage Board regular meeting minutes on April 15, 2019 as presented. Mr. Woodward 2^{nd} . Concurred by Mr. Gerber, motion carried 3-0.

Bowers Tile Drain-Harrison Township:

Mr. Hahn mentioned he received a call from a landowner about the Bowers tile drain in Harrison Township, section 31, range 12E having several holes and would like to replace about 1260 feet of existing 18 inch tile with a 24 inch at the very lower end where it empties into Rockcreek. Hahn noted that this watershed's maintenance was raised in 2003 to replace the tile as funds become available. Hahn mentioned that we have replaced about 1500 feet over the years with the very upper end left to be replaced in the near future. Hahn finally noted that the State Highway did replace about 500 feet that runs along on the south side of State road 218 in 2003.

2019 Drainage Projects Projection Cost W/Highway Information:

Mr. Hahn presented a detail spreadsheet of the drainage projects with their location, approval of watershed funds and landowner cost. Hahn mentioned the group projects are landowners helping with cost and may involve the county highway with a share-cost of that project and road cut and/or pipe replacement. Also, there are projects that are all paid out from maintenance fund but still may involve a highway cost for a highway road cut and pipes. The Group project listing shows that landowners are very active in the cost as well as the maintenance fund contributing. Hahn mentioned that he will give a copy of the spread sheet, and will talk to the County Highway supervisor and Engineer on all drain projects that will involve a cost-share. Hahn noted that some of these projects may be up to more than 1 year before it actually happens. Hahn mentioned that some of the projects landowners are not far enough along on how much they want to replace and finance therefore boxes are left empty. Hahn also noted that a couple of the group projects are being completed as we speak and a few are about to be put in as soon

INDOT-County Tile Replacements on State Road 1:

Mr. Hahn contacted the State Highway a year ago on replacing 4 tiles across State Road 1 before their paving project begins this year. Hahn mentioned the locations of the tile starting with the south end of the county starting with the McClain Prong 1 tile just is south of 1200S replacing 8 inch with a 12 inch (this is in Jay County but the tile is our jurisdiction), McClain tile at 1150S replacing two 12 inch with a 30 inch, north of 700S the King 8 inch replacing with a 12 inch, and then north of the county and north of 800N is the King Prong replacing 16 inch

Project Updates:

Char. Stinson Tile/Prong Replacement Phase #4&5:

Mr. Hahn mentioned that contractor Ramseyer Exc. has completed replacing the Charles Stinson Tile/Prong Group Project Phase #4&5 in Liberty Township, section 8, range 11E include crossing county road 200S. Hahn noted the contractor has a few connections to hookup. The project consists of replacing 1,000 feet of 12 inch with 15 inch, and 3,400 feet of 10 inch with 12 inch tile.

2019 Spray Program:

Mr. Hahn mentioned that spray notices will be going out in the mail starting today to the affected landowners in the north half of the County. Hahn noted that Chad Baker of Right-a-Way Management will be spraying this year and will begin next week of May 13th and weather permitting.
