Wells County Highway -Driveway Permit

- 1. Applicant will mark with wood stakes or colored flags the proposed location of the drive upon submitting this application.
- 2. The minimum pipe length shall be 20 feet. The minimum pipe diameter shall be 12 inches, unless stated differently.
- 3. The depth of the existing side ditch shall be defined as the vertical height as measured from the existing road berm to the bottom of the existing ditch.
- 4. Pipe bedding shall be compacted #73 or #53 aggregate.
- 5. Applicant will use the following: pipe material shall be dual wall high density polyethylene (HDPE), 14 gauge 2-2/3" x ½" Corrugated Steel pipe, or reinforced concrete (RCP) class IV.
- 6. Applicant, by executing this Application, agrees to hold harmless and indemnify Wells County and its agents, employees and officials from and against any claim for personal injury or property damage, caused or sustained by reason of the exercise of any work under this permit.
- 7. All construction will be inspected and approved by the County Highway Department or the County Engineer.
- 8. The County Engineer and Highway Department reserve the right to alter or adjust the proposed location of the drive for the purpose of improving sight distance.
- 9. This permit shall in no way limit or diminish any rights Wells County has in this right-of-way. In the event it is necessary or desirable for Wells County, its contractors, or agents to perform any maintenance, repair, alteration, or construction work in the right-of-way that results in damage to property or construction installed under this permit, Wells County shall require the owner or permittee to be financially responsible for replacement.
- 10. Applicant shall be responsible for any damage to any County facilities if the damage is caused by any installation under this permit.
- 11. All applications will be handled in a timely manner. Please allow up to 5 working days for the processing of a submitted application. If an application is rejected for whatever reason, the applicant will be notified. The application will expire 12 months from the date of submission if no work is performed.
- 12. Applications to enclose a side ditch must be accompanied by hydraulic analysis prepared by a registered professional engineer/surveyor providing evidence of the site or pipe's ability to carry all contribution offsite drainage and maintain roadside drainage in the area of the side ditch enclosure.
