ORDINANCE VACATING STREET

WHEREAS, on the 28th day of August, 2018, Douglas K. Roberts and Suzanne M. Roberts, husband and wife, petitioned the Commissioners of Wells County, Indiana to vacate a portion of South Street, Walnut Street and an alley located in Kingsland, Wells County, Indiana and more particularly described as follows, to-wit:

A PART OF SOUTH STREET, WALNUT STREET, AND ALLEY IN THE ORIGINAL PLAT OF KINGSLAND TO BE VACATED, BEING IN THE SOUTHEAST QUARTER OF SECTION 33, TOWNSHIP 28 NORTH, RANGE 12 EAST, LANCASTER TOWNSHIP, WELLS COUNTY, INDIANA, DESCRIBED AS FOLLOWS:

A PART OF SOUTH STREET, WALNUT STREET, AND ALLEY IN THE ORIGINAL PLAT OF KINGSLAND TO BE VACATED, BEING IN THE SOUTHEAST QUARTER OF SECTION 33, TOWNSHIP 28 NORTH, RANGE 12 EAST, LANCASTER TOWNSHIP, WELLS COUNTY, INDIANA, DESCRIBED AS FOLLOWS:
