WELLS COUNTY ORDINANCE NO. 2019-04

An Ordinance Amending Ordinance 2008-02 By Increasing the Fee Collected For Auditor's Endorsement Required For Recording Of Deed Of Partition, Conveyance Of Land, Or Affidavits Of Transfer To Real Estate

WHEREAS, a Plat Book Maintenance Fund was previously established by Wells County Ordinance 2004-01; and

WHEREAS, Wells County Ordinance 2008-02 was adopted increasing the fee collected for the Wells County Auditor's endorsement required for recording of deed of partition, conveyance of land, or affidavits of transfer to real estate; and

WHEREAS, Section 105 of HEA 1047 of the 2019 Indiana General Assembly requires that the legislative body of a county adopt an ordinance requiring the auditor to collect a fee in the amount of ten dollars (\$10) for each: (1) deed; or (2) legal description of each parcel contained in the deed; for which the auditor makes a real property endorsement. This fee is in addition to any other fee provided by law. The auditor shall place the revenue received under this subsection in a dedicated fund for use in maintaining plat books, in traditional or electronic format.

NOW THERFORE BE IT ORDAINED by the Board of Commissioners of Wells County, Indiana, as follows:

- 1. The Auditor of Wells County shall collect a fee in the amount of ten dollars (\$10) for each:
 - (1) deed; or
 - (2) legal description of each parcel contained in the deed;

for which the auditor makes a real property endorsement. This fee is in addition to any other fee provided by law. The auditor shall place the revenue received under this

ordinance in a dedicated fund for use in maintaining plat books, in traditional or electronic format.

- 2. All other sections of Wells County Ordinance 2004-01 and Wells County Ordinance 2008-02 shall remain in force and effect.
 - 3. This Ordinance shall be effective July 1, 2019.
