## WELLS COUNTY ORDINANCE 2020-

An Ordinance of the Wells County Board of Commissioners Amending County Ordinance 98-11 and Authorizing the Procedure of Indiana Code Section 5-22-9 et seq. to Award Contracts by Use of Request for Proposals or "RFP"

WHEREAS, Indiana Code §5-22 et seq. (the "Act") authorizes a purchasing agent of a political subdivision like Wells County ("the County") to award contracts for the purchase of supplies or services using the procedure provided by the Act, the use of request for proposals or "RFP", subject to the policies of the purchasing agency;

WHEREAS, the Act requires the County to request proposals pursuant to the Act before awarding a contract; and

WHEREAS, the County Board of Commissioners now desires to adopt the Act amending County Ordinance 98-11 and authorizing the procedure of the Act to award contracts for the purchase of supplies or services by use of request for proposals or "RFP".

NOW THEREFORE, BE IT ORDAINED BY THE WELLS COUNTY BOARD OF COMMISSIONERS as follows:

**Section 1.** If the County Board of Commissioners determines that it is either not practicable or not advantageous to award a contract for the purchase of supplies or services by sealed competitive bidding, it shall authorize the appropriate County purchasing agent to use requests for proposals (RFP) to award a contract for purchases of supplies or services.

**Section 2.** Adoption. The County Board of Commissioners hereby adopts Ind. Code §5-22 et seq., as amended, with the unanimous consent of the members present to introduce and adopt the ordinance at the same meeting or on the same day, and the ordinance is approved by a 2/3 vote of all the elected members.

**Section 3.** Governance of Act. The County purchasing agent shall comply with the process, procedures and requirements set forth in the Act to use requests for proposals (RFP) to award a contract for purchases of supplies or services.

**Section 4.** Effective Date. This Resolution shall be in full force and effect upon passage.
