GENERAL PROVISIONS

§ 70.01 ENGINE BRAKING PROHIBITED.

(A) *Definition.* **ENGINE-BRAKING**, commonly known as “jake-braking,” shall mean the use or operation of any mechanical exhaust device designed to aid in the braking, decompression or deceleration of any motor vehicle which results in the excessive, loud, unusual or explosive noise from such vehicle.

(B) *Prohibited acts.* It shall be unlawful for the driver of any motor vehicle to use or to operate or to cause to be used or operated, at any time and on any street or road over which the county has jurisdiction, any mechanical exhaust or decompression device which results in the practice known as “engine-braking” or commonly known as “jake-braking.”

(C) *Exemptions.* The provisions of this section shall not apply to the application of unmuffled compression brakes where necessary for the protection of persons and/or property which cannot be avoided by application of an alternative braking system. Noise caused by the application of engine compression brakes, otherwise known as “engine-braking” and commonly known as “jake-braking” which is effectively muffled or if the application is necessary for the health, safety, and welfare of the community is exempt from the provisions of this section. Sounds created by emergency equipment for emergency purposes are also exempt.

(D) *Posting of signs.* The County Highway Department is hereby authorized and directed to post at reasonable locations within the county signs indicating the prohibition of “engine-braking” and/or “jake-braking.”

(E) *Penalty.* A violation of this section shall be considered a Class C infraction under the terms of the I.C. 9-21-5-13.

§ 70.02 USE OF COUNTY ROADS; RESTRICTIONS OR PROHIBITIONS.

(A) The Board of Commissioners, by a majority vote, may restrict and/or prohibit the use of any county highway, by trucks or any other vehicle.

(B) Any prohibition or restriction regarding the use of a county highway shall be enforced after the placement on the highway, by the County Highway Department, of appropriate signs which indicate the restriction or prohibition as it applies to the particular county highway in question.

(C) Anyone operating a vehicle in violation of the provisions of court of competent jurisdiction, such decision shall not affect any other section, clause, provision or portion of this section.

§ 70.03 OFF-ROAD VEHICLES.

(A) Off-road vehicles may be operated, subject to all state laws and regulations and all local ordinances, on all roads within the county road system located outside the jurisdiction of any city or town.

(B) Off-road vehicles are limited to use of the traveled portion of county roadways.

§ 70.04 GOLF CARTS.

(A) *Definitions.* For the purpose of this section the following definitions shall apply unless the context clearly indicates or requires a different meaning.

COUNTY ROAD. The entire width between the boundary lines of every county way publicly maintained when any part of the way is open to the use of the public for purposes of vehicular travel within Wells County, Indiana. The term includes, but is not necessarily limited to, streets, alleys, roads, highways, or thoroughfares within unincorporated towns.

FINANCIAL RESPONSIBILITY. The meaning expressed in I.C. 9-25-4-1, et seq. (as it now reads or may be amended in the future).

GOLF CART. A four wheeled motor vehicle originally and specifically designed and intended to transport one or more individuals and golf clubs for the purpose of playing the game of golf on a golf course.

OPERATE. To exercise any control over the function or movement of a golf cart.

(B) *Unlawful operation of a golf cart.* It shall be unlawful to operate a golf cart on any county road or highway except as specifically authorized by this section. Any person who operates a golf cart in violation of the regulations set forth in this section may be punished by a fine of up to \$100 plus costs of this action and attorney fees, with the fine to go into the county's General Fund.

(C) *Requirement of local registration.*

(1) Any golf cart to be operated on a county road or highway shall be registered annually at the Wells County Sheriff's office located at the Wells County Jail. Each registrant shall provide the vehicle identification number and proof of financial responsibility with respect to each golf cart to be registered and shall pay a registration fee of \$30 for each golf cart to be registered. The registration certificate shall be maintained on or about the golf cart at all times that it is in operation.

(2) All monies collected shall go into the county's General Fund and any expenses with regard to the registration shall be paid out of the registration fee and the county's General Fund.

(D) *Requirement of driver's license.* The operator of a golf cart on a county road or highway must have a valid driver's license and must have the driver's license in his or her possession while operating a golf cart.

(E) *Requirement of financial responsibility.* No person may operate a golf cart on county road or highway unless financial responsibility is in effect with respect to the golf cart as provided under I.C. 9-25-4-4 (as it now reads or may be amended in the future).

(F) *Time of operation and nighttime restrictions.* No golf cart shall be operated on a county road or highway between one-half hour after sunset and one-half hour before sunrise unless the golf cart is equipped with two headlamps, two tail lamps, front and rear turn lamps, and rear brake lamps, all of which must be visible from a distance of at least 500 feet.

(G) *Requirement of red or amber flashing lights.*

(1) No golf cart shall be operated on a county road or highway unless the golf cart is equipped with red or amber flashing lights mounted at a height as low as practicable that are visible from a distance of not less than 500 feet to the rear. The red or amber flashing lamp may be used at times other than when lighted lamps are required. A double-faced flashing lamp may be used, displaying amber light to the front and red or amber light to the rear.

(2) Red or amber lights shall be used under all circumstances during which the use of lighted lamps on vehicles is required.

(H) *Place of operation.* No golf cart shall be operated on or at any of the following:

(1) Any county road or highway or any portion of any county road or highway where the speed limit in effect at the place of operation is greater than 55 miles per hour.

(2) Any county road or highway designated as a state highway, except to cross any state highway by traveling on a county road or highway perpendicular to the state highway at a location where the county road or highway intersects with the state highway.

(3) Any sidewalk, trail, or greenway path not specifically designated for use by a motor vehicle.

(I) *Traffic laws and ordinances.* The operator of a golf cart on a county road or highway shall comply with all traffic laws and rules adopted by the state and/or the county.

(J) *Occupants.*

(1) The number of occupants of a golf cart shall be limited to six persons if the golf cart is constructed for six persons. If not, the number of occupants shall be limited to the number of people the cart was designed to seat.

(2) The operator and occupants shall be properly seated at all times and no part of the body of the operator or occupants shall extend outside the perimeter of the golf cart while the golf cart is in operation; provided however, the operator shall use proper traffic hand signals when required. No one under the age of two years shall be permitted to be an occupant of a golf cart.

(K) *No towing.* No golf cart shall be used to tow any type of trailer or other vehicle of any type. (Ord. 2012-04, passed 6-18-2012)

PARKING REGULATIONS

§ 70.20 COUNTY ANNEX BUILDING AND LIBRARY; PARKING RESTRICTIONS; NOTICE.

(A) It shall be unlawful for the owner or operator of any vehicle to park in the County Annex parking lot immediately east of the County Annex Building unless they are involved in the legitimate use of the County Library or the County Annex offices.

(B) It shall be unlawful for the owner or operator of any vehicle to allow that vehicle to be parked overnight in the County Annex Building parking lot.

(C) It shall be the duty of every county police officer to issue a citation to any owner or operator of a vehicle being used contrary to this section. The citation shall bear the date, time and license number of the vehicle. It shall be either personally delivered or be placed on the windshield of the vehicle being improperly used.

(D) Each citation shall contain a notice to the owner or operator of the vehicle that they shall appear in the County Superior Court on a designated day and at a designated hour to answer to the citation.

(E) The County Attorney shall have the power to prosecute violations of the provisions of this section.

§ 70.99 PENALTY.

(A) Any person violating any provision of this chapter for which no other specific penalty is provided shall be subject to the penalty provisions of § 10.99 of this code.

(B) Any person who violates the provisions of § 70.20 is subject to a civil fine of \$50 per event, plus court costs as set out in I.C. 33-19-5-2 et seq., and those statutes pertaining to court costs for ordinance violations.
