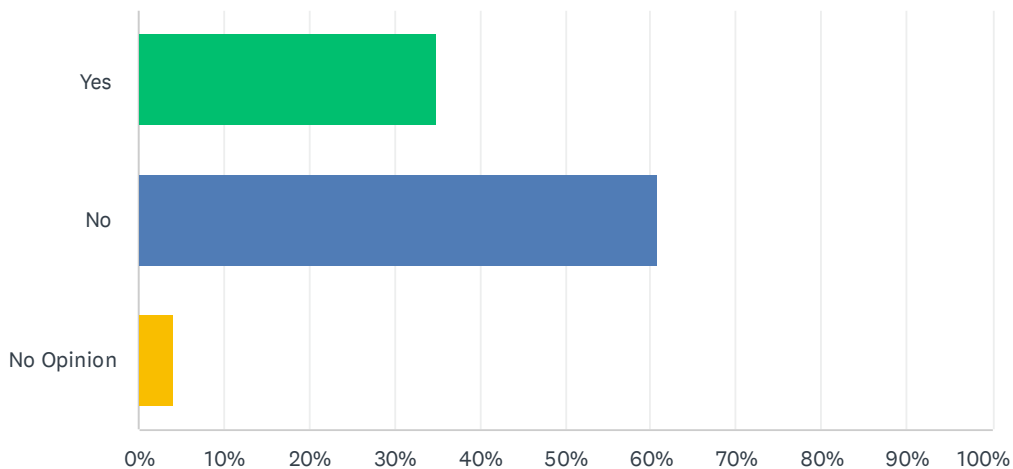


Q1 Should the Wells County Vision 2035 Comprehensive Plan support the development of solar in Wells County?

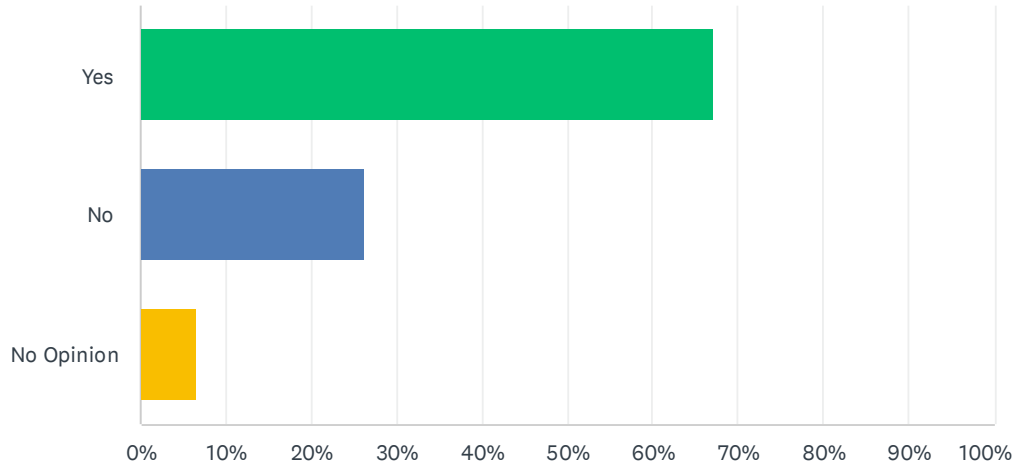

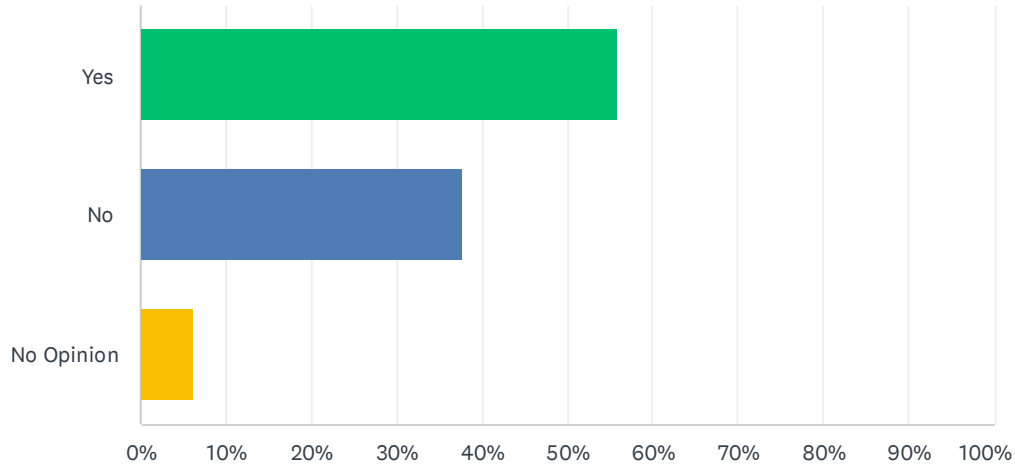

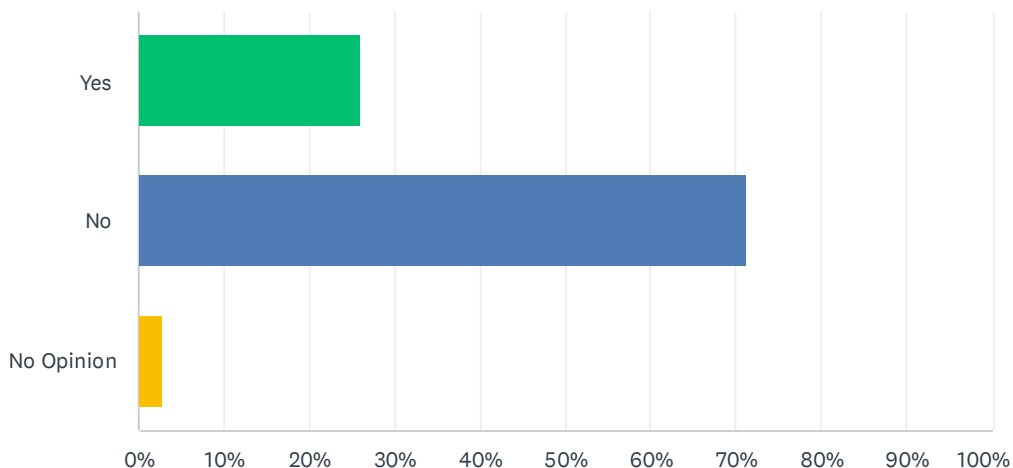

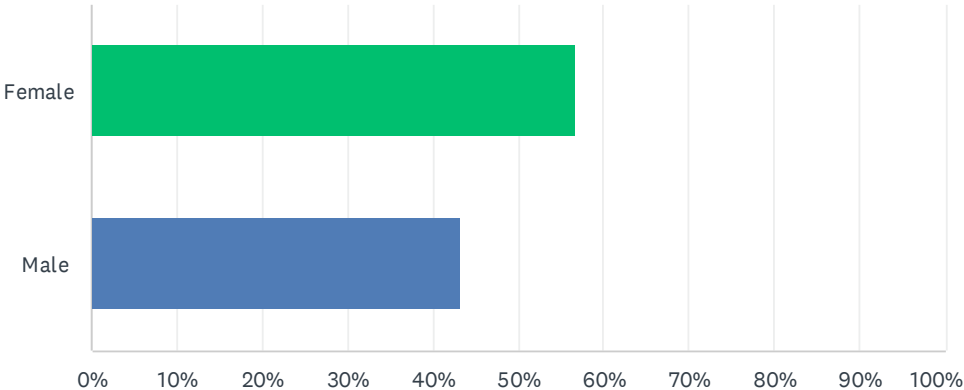

Q6 What is your gender?

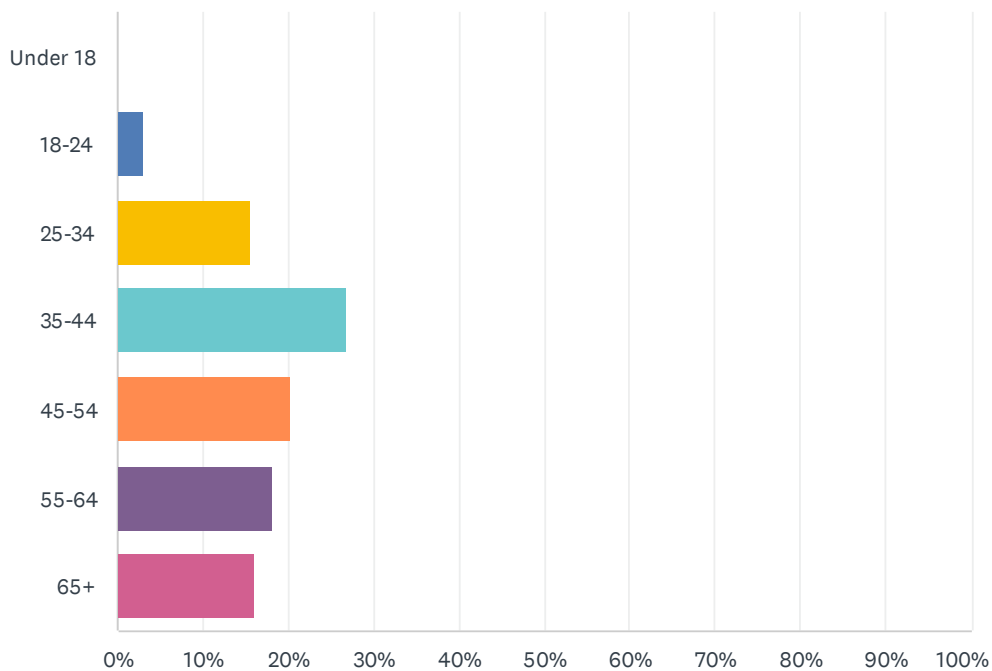

Q7 How is your age?

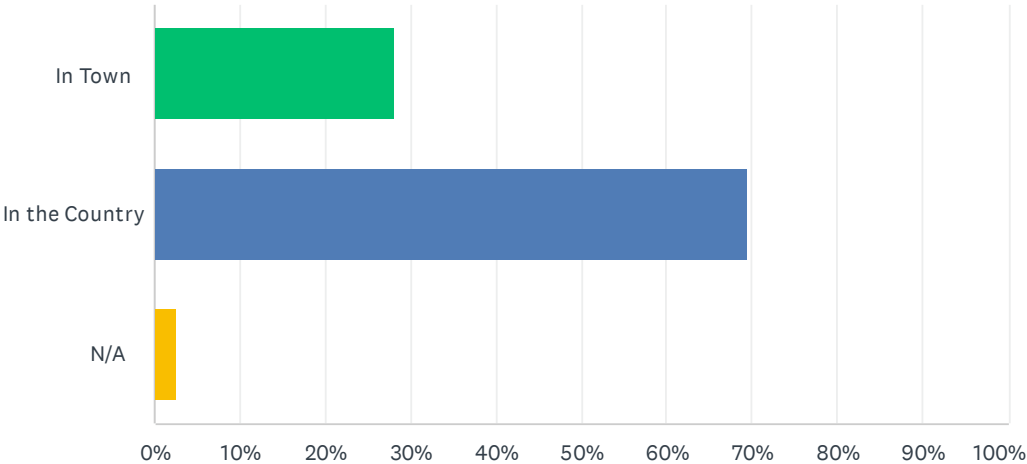
