This report provides a statistical breakdown of the volume and classification of criminal cases and charges, juvenile adjudications, and child support collection cases prosecuted and administered by the Wells County Prosecutor's Office in the year 2024. Below is a chart indicating the number of criminal cases filed in each of the last five years. Please remember that a case will often consist of multiple charges or counts filed against one individual and that a case is defined by the level of the most serious charge filed in the case. These numbers do not include the numerous traffic infractions which come through the county criminal justice system.
