**Welcome, Introductions and Call to Order:** The meeting was called to order at 11:30 am by Greg Werich. The board welcomed Vicki Bell, Boys and Girls Club Director, as a guest.

**Grant Program Reports:** Vicki Andrews reported on Southern Wells Jr/Sr High School's random student drug testing program and Stacy Morrison reported on Bluffton High School's random student drug testing program. Greg offered to make the Annual Program Report Form (used for grant reporting) accessible on the website.

**Presentation of Minutes:** The November meeting minutes were approved as written (Tammy motioned, Betsy seconded, unanimously passed).

New Members: none

Treasurer's Report: Stacy reported the checkbook balance remains unchanged at \$59.84.

# **Unfinished Business:**

• Greg opened the floor for nominations. The following nominations were made:

PRESIDENT: Greg Werich VICE PRESIDENT: Molly Hoag SECRETARY: Vicki Andrews TREASURER: Stacy Morrison

The nominations were closed and approved unanimously by the board. It was noted that co-secretaries may be needed in future as this position carries a lot of responsibility.

- Greg reported that the CADA handbook is almost ready and will be distributed shortly.
- The Special Events Committee (Molly, Roger and Brian) reported that there are several events in the works for an afternoon in-service or evening program on ATOD use. Those discussed were:
  - James Ginder, a Health Education Specialist with the Hamilton County Health Department, who talks about drug trends. Contact has been made with someone at the Health Department and this is a possibility.
  - O Sgt Dan Mawhorr, Indiana State Police, is working on a presentation about prescription drugs and heroine. He is willing to make the presentation once it is ready.
  - o "The Anonymous People", a documentary, about the 23.5 million Americans living in long-term recovery is available free of charge from DAC.
  - O A panel discussion on drug issues to include: DCS, Judge, BPD Chief, WCSD Detective, Park Center was also deemed as a valuable option to show how everyone is impacted by drugs in our community.

#### **New Business:**

- The Grant Review Committee (Molly, Betsy, Vicki, Angie) noted that there were fewer grant requests made this year; however, the money requested still far outweighed the money available. There was a total of \$9,268.88 available; \$2,317.22 in each of the four categories (administration, education/prevention, judicial, treatment/intervention). It was noted that the random student drug testing funding was based upon the number of students in the pool. The 2014 Grant Request worksheet was distributed to the board as a recommendation by the Grant Review Committee. The recommendation was approved as written (Tammy motioned, Kim seconded, unanimously passed). The Fund Information report will now be submitted to ICJI for approval. Once approved by ICJI, it will then be submitted to County Council and County Commissioners for approval. If all goes well, funds may be distributed by late March or early April. Molly will prepare letters to be included with the checks.
- The Northeast Regional Advisory Board (RAB) has been awarded a grant through ICJI. The grant is to create a collaboration of LCC's (14 northeast Indiana counties) to work jointly to utilize expertise and resources to address underage drinking in the region; this includes everything from programming to media pieces. The counties can chose to do any part(s) of the grant, but participation is not required. Kelly Sickafoose was present to talk about opportunities available to our county with the grant. The grant runs through May.

- The committee charged with creating the Drug Protocol Manual is currently collecting Key Partner Surveys. The manual is scheduled to be distributed by spring.
- The 2013 Annual Meeting of Purdue Extension was held on February 10, 2014 with Sgt Dan Mawhorr serving as the guest speaker. The topic "The Dangers and Risk with Manufacturing Meth" was very informative and generated a lot of guestions from those in attendance. The event was free and open to the public.

#### **Membership Sharing:**

- It was reported that the News-Banner wants to do a series of articles on Heroin (similar to the Meth series which ran in the fall).
- Kim conducted a training for Community Corrections on Mental Health and Substance Abuse issues.
- Mental Health First Aid is being offered on Tuesday, February 18<sup>th</sup> from 8:00 am 5:00 pm; there are still 2 spots available. The cost is \$40 with lunch and workbook included. Denise Wells from DeKalb County will be conducting the training at the 4-H Community Center. Contact Molly if you would like to attend.
- Park Center announced a new hire, Brandon Evans. Brandon is currently doing in-home case management and once he is licensed will be a therapist. They are very excited that Brandon has joined the staff!

Discussion as to whether we want to use the ACIG press release and/or newsletter that was presented. The committee said they feel it would be a valuable resource. Angie Dial will send out the flyer and Molly Hoag will send info to the News-Banner for a newsletter link.

**New Business:** Angie Dial and Greg Werich went before County Council and County Commissioners for grant allocations. The state has questioned the signals request from House of Hope so Angie has spoken with the state and House of Hope to get questions cleared up, as the state has questioned if the request qualifies for treatment with licensed counselor. Working with House of Hope to see if they can provide counselor information licensing, if that cannot be done, the committee may need to redo the percentages to redirect the allocations which would require going before the County Council and County Commissioners. Claims will be on hold until grant information is changed. We will wait for state acceptance of the grant. If approval is granted, then checks will be processed for grant.

Also stated that groups who have not made a report, need to make it before more money will be granted.

**Community Concerns/Trends:** WRAPP meeting will be the first Tuesday of the month.

Drug and Alcohol Consortium will provide training on Opiates and Opioids on Friday March 21, 2014, at the Allen County Library.



**Welcome, Introduction and Call to Order:** The meeting was called to order at 11:30 am by Greg Werich. Melissa Hayden from Wells County DCS explained and gave the group information about their website.

Grant Program Reports (2013): Alicia Hill gave a grant report for House of Hope. Help has been given through the CADA grant for tuition for student services, using much of the money for drug testing at the house. Many come from families with addiction problems. The new grant will be strictly used for drug testing for the boys. Jim Paxton reported that the Sheriff's department has purchased DARE book supplies for students in the schools. Also money was used for the canine training program. A.J. Campbell is a new canine officer and doing very well with his training. Randy Steele has been a canine office in the past. The canine program is a drug prevention tool. Rick Mettler reported that the Bluffton Middle School does random drug testing every two weeks for extra-curricular and co-curricular students. Only about 180 seventh and eighth grade students are eligible. Last year 72 tests were administered, no positive results. Parents can ask for testing of their student at the parent's expense. They have done the testing for 4 or 5 years now. They use ASL testing services.

**New Members:** None, however, Tammy Schaffer said she is retiring and Nathan Huss, the new Chief of Police will be attending the CADA meetings.

Treasurer' Report: None

**Unfinished Business:** Claims have been filed. Money would be available in 2 weeks. The change was made for House of Hope and it was approved. Their grant will be used for drug testing. Update from Molly on the ICIA grant articles submitted to the News-Banner regarding the use of the press relief. It will be put on page 5. Angie has a new flyer to distribute from this grant also. We can use the program and flyers they provide for more information. Two community groups have expressed interest for classes, they are Megan Workinger (Southern Wells Guidance) and House of Hope.

New Business: Awards banquet is usually held in May. It was decided not to have a banquet this year.

Community Concerns/Trends: Information was given about a new high end, hydroponic marijuana drug called KUSH.

Membership Sharing: June 2, 2014 Tammy Schaffer will be retiring from the Bluffton Police Department.

**Welcome, Introduction and Call to Order:** The meeting was called to order at 11:34 am by Greg Werich. The group welcomed Jessica Williams (Bluffton News-Banner) to the meeting; she will be observing the meeting and speaking with members for an article she will be writing on CADA in the 2014 Progress Edition of the paper.

**Grant Program Reports (2013):** All program reports for the 2013 funding cycle are now complete. The 2014 Program Report form will be emailed to all who received funding; it is encouraged to present the report as soon as the project is complete or when the grant has been spent down.

**Presentation of Minutes:** The April meeting minutes were approved as written (Tammy motioned, Rick seconded, unanimously passed).

New Members: None

**Treasurer' Report:** Greg reported that there has been no change in the checking account balance; it remains at \$59.84. He also reported that \$895.00 in drug and alcohol fees were collected in March (according to the Auditor's report).

**Unfinished Business:** Angie reported that the Strengthening Families training date has been set. It will take place on Friday, May 16 from 3-9 at DAC (Drug and Alcohol Consortium in Fort Wayne). This training is provided free of charge thanks to a 13-county regional grant.

Yard signs (talk to your kids about drugs) were distributed; these were also provided as a result of the regional grant. It is asked that the signs be displayed off and on during heavy traffic times of the year (back to school nights, events, etc). Do not dispose of them! We would like to move them around the county as needed. If you are done with your sign and do not want to store it for future display, email CADAofWellsCounty@yahoo.com or call 824-8574 and ask for Angie; we will get it to another location. There will also be compliance signs and clings, posters and magnets available in the near future.

**New Business:** CADA began the process of an address change at the end of April due to the cost of maintaining a PO Box. Greg arranged for CADA to have a collection box in the Auditor's Office of the Courthouse. A motion was made by Tammy; seconded by Betsy; and unanimously approved in support of the address change for CADA. CADA's new address is: 102 West Market Street, Suite 205, Bluffton IN 46714. Angie notified the Secretary of State as well as Indiana Criminal Justice Institute; Stacy has agreed to notify IAB; Greg will update the website; and Alicia has completed the change of address forms with the Post Office. Other updates will be needed on the Grant Application, Letterhead, and Handbook.

There will be a Regional Training on Friday, May 16th; some of the topics will include a Legislative Update, Social Hosting, and Lifeline Law. Mark your calendars for July 31st! The regional grant will be hosting speaker Jermaine Galloway.

Jermaine is a police officer and talks about substance use trends and media. Also, 2014 is the 25<sup>th</sup> anniversary of LCC's. The regional board would like to celebrate this milestone during the annual meeting on November 10th at Indiana Tech by presenting more awards and speaker David Parnell.

**Community Concerns/Trends:** Tammy reported that heroine is on the rise. She also reported that our local doctors are doing better with prescription drug dispensation. She noted that around 80-95% of the prescription drugs dispensed around the world are dispensed in the U.S.

Kim shared that they see high treatment resistance with meth; the success rate is poor. Meth use is devastating and it is hard to have success with outpatient treatment. They are seeing multiple relapses. Kids are being removed and meth is becoming very expensive for communities. They are noting major medical concerns along with the addiction and seeing no access to care despite the Affordable Health Care Act.

Alicia noted that they are dealing with entire families struggling with addiction.

**Membership Sharing:** Tammy will be retiring as Chief of the Bluffton Police Department effective Monday, June 2<sup>nd</sup>. Thank you to Tammy for her many years of valuable service to CADA. Assistant Chief Nathan Huss will be taking her place as Chief as well as on the CADA board.

Betsy noted that she has been forwarding the regional flyers to an Ossian PTO representative. They appreciate the information and have been displaying it for adults in the elementary school. Thank you Betsy for sharing the information with the community! Everyone, please share this information with others as well!

Alicia shared that they are receiving wonderful support from the community. They have begun partnering with other community resources to offer healthy alternatives to their residents. A men's fraternity has been mentoring their boys about being a good husband, father and man; the Bluffton Parks Department is offering their programming to the boys free of charge; the YMCA has provided free membership for the boys to use the workout equipment and other services; Wells County Probation has been conducting the onsite drug testing. The results have been very positive.

Rick is noticing that good healthy parenting is becoming a thing of the past. He noted that families are having difficulty balancing discipline with love and respect.

Changes in the criminal code take place on July  $1^{st}$ . It was noted that the categories will be changed to murder and 6 levels of felonies. More information will be available soon.

Park Center in Fort Wayne has opened a new inpatient unit.

Welcome, Introductions and Call to Order: Molly Hoag at 11:30 am

**Grant Program Reports:** None – Angie will send out an email reminder of reports that will need to be presented in the next few months.

**Presentation of Minutes:** The July meeting minutes were approved as written (Betsy made the motion, Stacy seconded, unanimously passed).

**New Members**: No one eligible for membership at this time (membership requirement: participation in 3 CADA meetings).

**Treasurer's Report:** Stacy reported the checkbook balance to be \$59.84; a \$20 check was written for Angie to attend the Northeast Regional Training.

## **Unfinished Business:**

• Molly reported that Greg Werick suggest we drop our non-profit status. We only have to file the IRS Form 990 because of our checking account and those funds are small enough the bank would like to charge fees. He feels it is more of a liability. Angie will check on other groups to see if there would be a reason to continue the non-profit status. After more information we will make a decision on what we will do. The decision was tabled and will be continued at a later date. We will also find out how to terminate the status.

# **New Business:**

Time to start community plans update of funds. Angie will get information out that we will need before October 31, 2014. Programming data also will be needed. November 10, 2014 will be the annual meeting with David Parnell, speaking. Nominations are needed for program of the year or person of the year.

## **Community Concerns/Trends:**

Alicia Hill of Park Center has expressed a serious concern about the increase of heroin and meth patients who have been frustrated with detox and admission of services facilities. Doors get closed when they hear of people with abuse that need help. Inpatient and out-patient treatment for people who are admitted, then the patient leaves before treatment is served.

House of Hope is having problem with some of the boys and their families.

Suggestion to possibly have Sargent Mahore to speak and have a panel to discuss what is going on and educate all groups as to what is going on in the community with the increase of drug use. Need to also get the medical personnel involved. Molly has been invited to a group discussion at the hospital and feels there would be a lot to share with the group and community. Nathan Huss expressed the concern that there are no longer inpatient services for these people. The abusers are either put in jail or settled down and sent back home. Many

domestic violence calls are related to drugs, alcohol or relationship problems. The jail has been the inpatient service in recent times.

# **Membership Sharing:**

- October 9, 2014, a luncheon meeting will be at the House of Hope. Molly has information on a free webinar for rural children's health and well-being. Molly and Angie went to a seminar on drug availability, given by Officer Jermaine Galloway on how individuals are using marijuana and processing it in different ways, such as vapors, and different devises. Also, on states that have legalized marijuana and how they are dispersing it.
- Ride for recovery is September 6, 2014 anyone can ride or volunteer to help.
- Regional grants have been used to purchase magnets and posters.

Angie checked with the IRS and the 990 Post card is all we need to file. Indiana criminal justice institute states that the only reason we need non-profit status is for grants.

The CADA grant helps pay for drug testing on the boys. The next report was made by Brian McClish from the Ossian Police Department. The CADA grant funds are used for purchases and training on cell phone information that can be confiscated. Greg said the probation department has already used the technology for their purposes. Angie stated only 2 months to complete your reports.

**New Members:** A member in good standing must attend 4 meetings per year. Removal of member because of non-attendance was approved for Paula Beck, Adams Wells Crisis Center, Sargent Todd Reed and Jim Paxson, Sheriff's Department. Binders and CD's will be available. Angie has sent out a flyer about the drug gravel, it has been found in Adams County.
