Welcome, Introduction and Call to Order:

Meeting was called to order by President Mark Misch at 11:30 am.

New Members:

Jade Glover has met the meeting requirements and is eligible for membership. It was unanimously approved to instate Jade as a member of CADA (motion by Molly; second by Andy).

Grant Program Reports:

- **Brickhouse Family Ministries** – Adam Carroll reported that they received \$800 from CADA that was used for testing supplies (\$759.09 for drug screens and \$400 for probation testing). The program provides prevention and intervention by helping families address the issue of substance use.

Presentation of Minutes:

The December minutes were unanimously approved as submitted (motion by John; second by Nathan).

Treasurer' Report:

A checking account balance was not available.

Drug Free Community Funds:

- 2017 total \$14,393.50 (distribution will be recommended at February meeting)
- January 2018 posting \$637.50 (for 2019 distribution)

Vicki moved to accept the report; Betsy seconded.

Unfinished Business:

- A 2018 CADA Handbook was emailed on December 14 for review. Updates include 1) the date on the front cover, 2) the addition of 2017 recognition recipients, 3) a revised membership roster, and 4) a modified annual checklist. The revision was unanimously adopted (motion by Molly; second by John).
- There was no update available from the Event Committee.
- The Grants Committee reported that 2 applications have been received; the deadline is Friday, January 26, 2018. The application was emailed in PDF format on 12/14 and in Word format on 1/5; it is also available on the CADA webpage. The committee will make a recommendation to the membership at the February CADA meeting.
- A notice was made regarding the 2018 schedule: the January, February, March and August meetings will be held at FCS; all others will be at the 4-H Community Center (no meeting in July).

New Business:

- It was preferred to hold the Annual CADA Awards Luncheon in the spring. A committee was formed to plan the event for April 12th from 11:30-1:00. The committee includes: Jade Glover, Molly Hoag, Vicki Andrews, Mark Misch, Alicia Hill and Angie Dial (notes). The committee will decide on location, food and awards. Adam will check with Alicia regarding burgers. Please relay any recommendations for Professional, Volunteer, and Friend of CADA to any committee member listed above. Angie will email a "save the date" along with an explanation of the 3 categories for recognition.

Community Concerns/Trends & Membership Sharing:

2018 Regional Advisory Board events (Quiz Bowl 4/28/18, Ride for Recovery 9/8/18, Regional Training Galloway 9/12/18, Annual Training Luncheon 11/30/18).

WRAPP will be changing from ASANA to Freed Camp as a communication tool. An email will go out with instructions to make the change.

The Bluffton Police Department have been busy with drug arrests and new investigations. Jeremy Heckel (WCSD Detective) was in attendance; he works the drug cases alongside BPD.

Brickhouse Family Ministries have hired new House Parents who will be starting shortly.

Wells County Council on Aging offer free tax preparation through AARP; there is no age limit and no fee for the service.

Alicia reported that Bowen Center is still working on expansion of mobile services; they will be up to 5 employees for Wells County by the end of the month.

Molly announced the second webinar in a series on the opiate crisis will take place on 1/17/18. The webinar is entitled "Recognition and Stigma in Prescription Drug Abuse and Alcohol Abuse". The series is a partnership between Purdue Extension and North Central Regional Center for Rural Development. Information was emailed on 1/5/18.

Jade distributed flyers for the Parent Café held on the 3rd Wednesday of each month at FCS from 5pm-7pm. The open event provides support and encouragement to parents and families. There is free childcare, transportation and a meal. Participants can RSVP by contacting Jade at FCS ... 824-8574.

Mark shared that the mental health issues they are seeing are different than even those of just a few years ago. Many also have a drug connection. There is a greater awareness and more help for students than in the past.

There was an open discussion regarding the cost of Sam Quinones (\$6,000). Many voiced concern that very few people would recognize his name and that his message may explain the trek of the opioid epidemic but may offer less insight on a solution. We may draw more interest if we provide local speakers/panelists who are in a position to enact change such as Jim McClelland (the drug czar for Indiana), a speaker (or panelist) from the Bowen Center's training institute, a peer recovery specialist, legislators (Senator Merritt), etc. There is also a mayor in TN or KY that is leading the charge to sue big pharma. Also, it is important to include stories of recovery which provides a message of hope. The September 2017 event was successful and was provided at no cost to CADA. It was thought that it was a good stepping stone to a larger event of a similar nature.

It was suggested that the Event Committee work towards offering something similar to the Adams County Drug Symposium held in July: Alicia Johnson, Jade Glover and Molly Hoag will join the current committee to organize the event.

Treasurer' Report: There is a balance of \$169.27 in the checking account
Drug Free Community Funds:

- 2017 total \$14,393.50
- 1739.50 posted in February

Unfinished Business:

- Event Committee Update - There was discussion about hosting a local event. Several met to discuss a potential plan for educational/training day similar to what Adams County presented last summer. It was proposed to have a legislator speak in the am, followed by law enforcement regarding current trends, then a success story, a speaker representing treatment/intervention then wrap up with another recovery story. Local vendors or providers could set up a table for the event; CADA would also have a table filled with resources. A tentative date of June 13th (possibly from 10-2 or 9-2) at the 4-H Community Center. Lunch would be provided and with hopes of making it free or donation at the door. February 26th at 10am at FCS is the next committee meeting.
- The grant committee met this week and there were some new applicants this year. There is also more grant money to disperse; \$14393.50 was collected with over \$17,000 in requests, allowing for \$3,598.38 for each category. It was recommended to increase

administration costs to \$500 this year to allow additional funds for expenses related to meetings and trainings. The amounts granted to the schools is based on population. The grant amount allocations were presented and explained.

- The grants will need to be approved by ICJI, the County Commissioner and City Council prior to the actual grant disbursement. Motion to accept and seconded for the grant recommendations, one opposed, voted carried.
- Discussion about what happens to the money for Sam Quinones if this is not scheduled. If the event does not occur then the money would remain in the fund and be rolled over for disbursement in 2019.
- Award Luncheon Committee Update – The committee met prior to the CADA meeting today and has formalized most plans for the luncheon scheduled for Thursday, April 12th. Members are encouraged to bring other community partners to introduce them to CADA. Recognition will take place in 3 categories: Friend of CADA, Volunteer Leader and Professional Leader. Brickhouse Family Ministry has offered to provide the burgers/buns/condiments again this year. A sign-up sheet was passed around at the CADA meeting for the remaining items needed for the luncheon. A flyer will be sent out to share for inviting other professionals or the public.

New Business:

- Appoint CCP Committee – Jade, Angie, Nathan, Deane', Mark. A new CCP is written every three years; the current plan will be updated for the last time in October and a new plan must also be submitted in October.

Community Concerns/Trends & Membership Sharing:

Angie – new program ICJI manager Lauren Savitskas.

Molly – Misty Young is a student doing a research project and is looking to interview people for that project. Anyone interested in assisting can email Molly. Misty will be attending the March meeting.

Jana Taylor - Adams Wells Crisis Center is hiring; it's ideal for anyone wanting some extra hours. Must be 18, have a valid driver's license and pass background checks. They may apply online through the website.

Betsy – They are offering free tax prep at Council on Aging. May 3rd is Wells County Resource Fair sponsored by the Wells County Council on Aging.

Nathan – The department had 2 narcan saves in January, with multiple doses. EMS may have had one and county had one.

Jade - Parent Café on February 21st. She passed out invitations to share; this month's theme is "Say it With Love". Parents can come, enjoy free dinner, childcare and transportation through WOW if needed. You must RSVP. It is half filled at this time.

John Cole - Community Care received a grant from Lowes and got grant for \$65 for and still need an additional \$65-70 to open.

Mark - Mental health issues seem to be increasing with the students; there are often underlying substance abuse issues as well. Things have changed in recent years with an increase of more of these issues for teens.

Presentation of Minutes: The March minutes were unanimously approved as submitted with the requested edits to dates and also corrections.

Treasurer' Report:

Drug Free Community Funds:

Unfinished Business:

- Grant committee, - Checks went out May 7th and got acknowledgement that the funds were released for the grants and the checks were mailed out. Grant recipients should check to make sure that they have received their funds.
- 42 people attended the Luncheon and was successful. There were new faces and thanks to everyone who contributed and special thanks to Brickhouse for their burger donations again.
- Event Committee Update – The flyer has been sent out for Real Recovery Program. We need submissions for attendance and currently have 15 participants. Speakers have been arranged and then now there is only one recovery story and one survivor story. Please submit your registrations and payment for the event by June 1st at FCS. There will be a special guest also attending.

- Dreamland/Sam Quinones update – funding is now secured. Save the date will be send out shortly to the community partners. Joan has talked with library and YMCA to support the event and get the word out.
- Mark Misch will be resigning as president of CADA due to a change in his position at Norwell. Per the handbook states that the Vice president could fulfill the vacancy as an option. Mark suggested that we attempt to fill for next year. Took suggestions of volunteers. Joan offered to assist Molly and fill for the vacancy. Jade Glover also volunteered to fill vacancy. Jade was unanimously voted as acting President of CADA for the remainder of the year starting with the August meeting.

New Business/Community Concerns/Trends & Membership Sharing:

- Interim director for Adams Wells Crisis Center – Barry Humble shared that they are in the process of selecting a new director and getting candidates. His work with the crisis center has brought attention to their residents having issues relating to substance abuse. He stated that there needs to be a discussion about how best to serve our clients. He stated that they can be contacted for support and information if there are concerns with a client to identify their needs. He stated that they are making a bank for community donations. They will have this at events and in the community and it is also mobile and can be put at any location on request.
- Roger Scherer – 4H has the summer backpack program getting ready to start. They are getting summer food resources for the program. They have 100+ recipients that get these backpacks. Anyone with information about other programs could be helpful to know about. There will also be free lunches through the Parks program.
- DMHA has put their backing behind LookupIndiana.org. There is now a community page for each county. Please send the information to John Cole SOC Coordinator. There is also good information on this site for many categories. Trainings or events can be put on the page. Also information about certification and trainings is available as well as who is certified in the community will be added.
- Joan Moon – when Sam comes, if you have read the book, he really represents the police, nurses and other in the community and it is hoped that we can get a good response and encourage supporting this event. Joan shared that her grandson is doing well and now employed and has been drug free for 2 years.
- Jade Glover share that Parent Café is going well and is open for families to attend with healthy interaction modeling the 5 protective factors. Food is provided with attendance and participants can receive a \$10 with gas card.
- CADA recognized Mark Misch’s work with CADA as President. He shared that they had one positive THC at the school and this was a positive intervention with a youth.
- Andy Ellis asked about youth and vape pens at schools. BPD have found some with THC in them.

- Deane' Holderman shared that Forensics Fluids has reported that clients using CBD oil should not have positive screens for THC. Information was shared that CBD oil is legal and can be purchased through local legitimate places. CBD oil that is obtained online may not be as reliable. CBD oil is supposed to have multiple health benefits but the THC is removed and does not have make a person high or have an intoxicating effect.
- John Cole asked about Vivitrol access at Park Center and how is has been utilized.

Grant Program Reports: No report this month

Presentation of Minutes: The May minutes were approved with the requested edits and corrections.

Treasurer' Report:

Drug Free Community Funds: June deposits of \$1475 with total of \$9571 total for the year

- No new information in checking account
- Part of the monies for Sam Quinones has been received and will be processed through the account
- Monies from Real Recovery, CADA grant of \$500 for event. We brought in 410 and had 41 paid meals in attendance. 3 speakers were there and \$47.67 due for mileage. Due to money brought in the \$500 was not utilized for the event. These monies were in the administrative funds for community education. These monies could be used for another event later this year if needed.

Unfinished Business:

- Real Recovery - We had 45 people in attendance on 6/13/18. Presenters included, representatives from Legislation, LEA and Treatment with 2 recovery stories. A short evaluation was given to participants with positive responses. More information will be shared when they are reviewed. We may need to utilize a microphone in the future for presentations. Survivor video was good, but difficult for some to hear.

- CCP committee - Nathan, Mark, Deane and Molly and committee members. We have met once and we will have more information coming. If CADA members know of something for grants that they are wanting then it could also be talked about so the plan can be inclusive.
- Dreamland/Sam Quinones update – funding is now secured and have additional \$500 and total budget is \$8000 which is all secured. Save the date will be send out shortly to the CADA Members and community partners and can be shared with others. It is hoped to have at least 100 in attendance for the event. The library could also be a resource to get the word out about the event. Sara/Library. There will be vendors at the event. There was a question about the need for video support for the event.
- Molly stated that the Chamber would be a good outreach to utilize to get information out to the public for services. The Chamber also had a committee at one time and it would be great to get someone from the Chamber to participate with CADA. There is a meeting on third Tuesday of the month and she could also share the CADA information to the Chamber and partnering with them. She will bring the information to Chamber that wants to become more involved. It was suggested that CADA do a presentation to the chamber, or someone from CADA to become involved in one of the Chambers Committee's. Sara Campbell could be contacted also. Joan will add her to the distribution list.
- There was a discussion about Anonymous People movie, but no monies would be needed to show this. It was discussed that a speaker would not be needed, nor would there be an expense to this. There is no date set for this at this time. A committee could be formed to set this up as a community event.

New Business/Community Concerns/Trends & Membership Sharing:

- Andy asked if the \$500 could be used toward printed out material for resources to give out to the community. Discussion was about something to pass out at street fair or have available for law enforcement. Possibly a magnet or mailer to community. Major Ellis stated that often info from street fair ends up thrown away. Andy stated a magnet with information to assist. This will be put back on August agenda to discuss and possibly come up with a committee.
- Valerie stated that Park Center's treatment facility will open next month and that is a 30 day residential in Allen County. She has also seen a couple cases of meth induced psychosis which is lasting longer that had previously. They are also seeing more methamphetamines and marijuana. Park Center has MAT and also inpatient and a full arrange of services similar to Bowen Center. There is information in regards to Winchester House with is an addictions center for women and children.

- Sonya was here with David and we will have a new representative for ICJI. She was asked about changes or things to be aware of. DMH grant should be considered going forward which would give us additional staff 1.5 persons full time employees. It could provide hard copy information, billboards and they could assist with writing the grant. It has to contain youth and addictions focus. ICJI grants are often labor intensive but she would assist. Andy stated that there is much paperwork attached. Angie will get more information about this grant. They will also help write questions for a needs assessment for the community if we are interested.
- Deane', DCS has current job postings for full time clerical and temp legal clerical. DCS continues to see trends with methamphetamine use opposed to heroine.
- Andy shared that methamphetamines, marijuana and spice is being seen locally. The chemicals that they are using on spice could be anything and everything. Andy says that they are moving towards arrests when possible due to a higher number of people leaving hospital after overdose and leaving AMA.
- Joyce Arnold is new executive Director of Adams/Wells Crisis Center.

Unfinished Business:

- CCP committee Update – The update has been completed and requests have been sent out for the data to put in the report.
- Dreamland/Sam Quinones update – All the invites are going out for the event and is now posted online and also on Event Brite. Flyers were passed out and also cards to advertise the event to be passed out.
- \$500 Administrative Funds – unused for Real Recovery. FYI to members

New Business:

- The Anonymous People Showing- Committee Appointments, looking for persons interested in forming a committee to have this shown in the community. Jade, Molly and Vickie agreed to participate in committee. A meeting date TBD
- Breanna's Hope. A better life– presentation. Support/Recovery Group. There are 26 chapters across Indiana and in Ohio. New Chapters are opening all the time. They are not a traditional 12 step and have their own curriculum. Some chapters are going into jails. They have sent over 600 to rehab and financed. They also speak to school age children and presentations. They have seen a reduction in drug related overdoses in communities where they have active Chapters which area attributed to multiple factors and combined efforts with LEA and other providers. They need to team leaders to start and facilitate a group. One member is supported by pastoral support and ideally the other would be a recovering addict.

NORWELL MS – Holly Morgan assistant principal – Random Drug Testing Program. She stated that is a good program and has been a good deterrent for students. Holly shared a story about an uninvited guest at a school party and had brought a Juul (vape). The parents intervened and asked the guest to leave and the students. 97% of the students are in the drug testing pool. 881.61 were grant money. ASL labs in Elkhart. They test 2 students weekly and numbers are sent at random and tested in the clinic. The tests are oral swabs 54 students were tested last year and all were negative. It continues to be a good deterrent. They are trying to pull students at different times of the day to be less of a disruption. The consent for the program is also completed online.

NORWELL HS – Norwell HS also presented as to their random screen program. Natalie Swineford, nurse. Their program again is very similar to the 812/761 is in the consent pool for random drug screens. They complete 5 random screen. They received over \$1100 to assist with paying for the screens. 2% were positive for nicotine use alone. She also reported that they feel that this is really working to keep drug use out of the student population or support that the students are not using drugs or tobacco products

DETECT DRUG TASK FORCE - Andy Ellis BPD is reporting. They utilize the monies for equipment that they utilize using drugs buys for prosecuting drug related charges. The equipment is not provided due to confidentiality as to what it is used for. It has been an improvement over the last equipment purchased. Covert recorder.

Sam Quinones event – Joan reported, \$1000 donated for \$80000 and utilized all except \$500. the Foundation would like the excess monies to be used toward another speaker. Jim Banks representative was present and sent a letter. Evaluations were shared with a participant sharing about their family member get back into treatment as well as a request to get treatment back into the jails. Joan will be back in April.

Grant Program Reports or Resource Presentation:

Bluffton MS – Grant monies went to drug testing with the 7th and 8th graders which is mandatory for the kids involved in extra-curricular activities. They administer 2 tests per week during the school. It is incentive for students to remain drug free. They have completed 24 to date of which all have been negative.

Bluffton HS – Grant monies went to drug testing for student drivers and students involved in extra-curricular activities. It is also incentive for students to remain drug free. They test 5 times a week. 95.6 %, 1 positive for marijuana and 1 positive for codeine.

Wells County Probation – Drug testing for daily call in for offenders. Re-entry, disruption noted case, or current offense for drug alcohol case and intensive supervision programs. They purchased 325 instant test kits. 19% positive for call in. 46% for probation. This is seen to be positive outcomes in keeping substance abuse down in their population

Wells Sheriff Dept. – Detect Program which uses phone cards for their equipment. Jeremy stated that there are 32 new cases where these are utilized. They assist LEA in keeping in touch with participants in the community

Southern Wells – Drug testing for students with around 12 per month, only 1 positive for nicotine. They have also seen a rise in student's vaping. They see the drug testing program as beneficial. AD will be taking over her position in CADA. They also have SRO which is assisting with the program. Assistant principal/Athletic director

WOW – Betsy Area on Aging – provides free transportation to NA, AA and substance abuse groups 450 trips for this year. This is an increase from last year. They are working close with Park Center to ensure that participants can make it to their substance abuse programs. They could also begin to provide transportation to Breanna's Hope next year when this begins at 6pm on Wednesdays.

Helping hands Pregnancy Center – Baby and Me Tobacco Free. Shawna reported that there have been changes with grant funding so they sought others monies to support the program and got sponsors for the program. Monies were to be used to purchase Carbon monoxide meter which measures potential tobacco use. They have seen a decrease with tobacco use with expecting mothers. They have had 1 mother complete the program in the last year. They are not seeing it being utilized to the level that the

community would need and have discontinued the program for 2019. They have decided to return the funding CADA provided \$684.50. Discussion was around if the meter would be useful outside of the program to support tobacco cessation. She stated that they can utilize it and their current meter can meet those needs. They are beginning another curriculum with expecting mothers on remaining drug free, which the monies could be utilized towards this program. Shonna can give information about the program and Board could approve. Families in Substance Abuse Treatment and Recovery. CADA would agree for them to utilize the monies to go towards this program. They will submit a progress report to be submitted to CADA. This will be put on the agenda for next month.
