**Grant Program Reports or Resource Presentation:**

Brickhouse Ministries – Alicia Hill gave information about their program. IT is a residential program ages 13 -17 boys. Family involvement is required. January of 2017 brought on the issues of more drugs other than marijuana, without treatment, drug addiction, prison or death. In 2018 they made significant changes to their program to address heroin and opiates. etc.. Adam Carroll is the new executive director, but Alicia continues to be involved. They have added more wraparound support services and aftercare into their program Their CADA grant has been used for drug screens. They have only used \$433 of their funds and would like to roll over the rest of the grant monies for the upcoming year. They continue to do drug testing with their boys after their return home to assist with aftercare. They received \$1200 and used \$433. They test for tobacco and alcohol as well.

**New Members:** Anita Miller and Laura Donatelli have met the meeting requirement and have agreed to become official members of CADA. Ben Burman made a motion; Stacy Morrison seconded; motion passed unanimously. Welcome Anita and Laura!

With the completion of the new grant cycle, everyone will be asked to complete a new Conflict of Interest statement. This process will continue throughout the year.

**Grant Program Reports or Resource Presentation:**

Family Centered Services requested to rollover \$487.50 of funding received in 2018 towards 2019 programming. The funds will be used for the same purpose they were awarded; to offset the cost to juveniles attending SIGNALS, DETOURS and Freedom From Tobacco classes when referred to do so by Wells County Teen Court. In 2018, only 5 juveniles attended DETOURS and no juveniles utilized the SIGNALS and Freedom From Tobacco classes. Only \$112.50 of the \$600 grant was spent.

So far in 2019, 13 juveniles have been referred to Teen Court. Currently, 1 juvenile has been assigned to take the SIGNALS class (\$90); 2 are in the process of taking the Freedom from Tobacco classes (\$90); 8 juveniles attended DETOURS in January (\$180); and 12 juveniles are registered for DETOURS in March (\$270) for a total spent of \$630 so far in 2019, depleting the rollover funds.

If the 12 juveniles referred for MIPA are assigned the SIGNALS class, another \$1,080 will be needed to help cover the cost of those classes. Juveniles pay 25% of class costs with CADA picking up the remaining 75% to help keep the costs reasonable for a typical teenager to pay.

John Cole moved to allow the surplus to roll over into 2019 to be used for the same purpose; Molly Hoag seconded; motion carried unanimously.

**Presentation of Minutes:**

The January 10, 2019 minutes were approved with the following additions: Adam Carroll, Alicia Hill and Laura Donatelli were in attendance; and a date change from January 10, 2018 to January 10, 2019.

Molly Hoag made a motion; John Cole seconded; motion passed unanimously.

**Unfinished Business:**

Helping Hands Pregnancy Resource Center has requested to rollover \$684.50 in unused funds due to the discontinuation the original program, Baby and Me Tobacco Free (a CO2 meter is no longer needed). They requested to put the funds towards a 17 week program entitled: Parenting Classes for Parents in Substance Abuse Recovery. The classes offer parenting skills with a focus on treatment and recovery; with a curriculum for the children as well. They hope to reach 10-12 adults and 20-24 children with the new program. The classes are meant to complement existing treatment and support options the family may already be utilizing. They would like to provide the class at no cost or low cost to the participants. The funds would be used to purchase workbooks, print pdf resource materials and to provide developmental resources for the children. The class would also be offered to parents or partners of those in recovery. Shawna Hamilton plans to attend future CADA meetings and hopes to have an update in May after the pilot.

Molly Hoag moved to allow the surplus to roll over into 2019 to be used for the Parenting Classes for Parents in Substance Abuse Recovery; Stacy Morrison seconded; motion carried unanimously.

The Grant Review Committee (Stacy Morrison, Molly Hoag, Vicki Andrews, Deane' Holderman, Holly Morgan) made a recommendation to the board. It is as follows:

It was discussed that all grants submitted meet the requirements. The Grant Review Committee recommended to fully fund all grants as requested; then open up another grant cycle mid-year in Treatment/Intervention and Judicial to try to distribute the remaining funds (\$1,630.93). Greg Werich made a motion; Pastor Lyle Breeding seconded; motion passed unanimously.

CADA is on the March 4<sup>th</sup> agenda for County Commissioners (9:00 am) and the March 5<sup>th</sup> agenda for County Council (7:00 pm). Everything is pending approval of the Comprehensive Plan and the Fund Information Report from ICJI. Funds cannot be released until that approval is received.

#### **New Business:**

The Annual Recognition Luncheon has been set for Thursday, May 9 at 11:30. A planning committee was appointed (Kari Adams and Jade Glover).

No action was taken on the handbook as it was previously adopted at the January 10, 2019 meeting.

Angie Dial reported that the taxes for CADA were filed (990N-epostcard and NP-20) on February 22, 2019.

Angie also reported that Grace Dickinson is the new Region 2 Program Manager. All documents that were previously sent elsewhere for approval have been sent to Grace as of February 11, 2019. Michael Ross (our previous contact) is now the Division Director.

**Member sharing /Community Concerns and Trends:**

- Angie shared a question from Kosciusko County regarding where law enforcement disposes of the deposits in Rx drop boxes; Betsy suggested contacting their local Triad Council or Indiana State Police post for more information. Sheriff Holliday or Assistant Chief Ellis may also be able to help.
- Molly gave an update on the proposed vaping tax. It has passed the House and will go on to the Senate. The tax will be attached to the purchase of the liquids used in electronic cigarettes (4 cents per milliliter). The hope is to discourage vaping, especially with young users. The tax could bring in as much as \$2-4 million per year to the state.
- Molly also invited anyone to the Purdue Extension Annual meeting on Thursday, February 21 at 6:00. The meal is free; however, RSVP's need to be called in to Purdue Extension by Friday, February 15<sup>th</sup> (824-6412). The speaker is Peter Goldsbrough from Purdue who will be speaking about GMO's.
- Jade reported that A Better Life – Brianna's Hope (ABL-BH) is taking place on Monday evenings from 6:30-8:00 at Sonlight Wesleyan Church. All is going well. The meetings are open to all who struggle with addiction and their support systems.
- Pastor Lyle distributed information packets for the upcoming "Break the Cycle" Bike-A-Thon to benefit DARE and A Better Life-Brianna's Hope. The ride is scheduled for April 27 at Ouabache State Park. The event is for all ages and many activities will be offered along with the ride. You may register online at [www.sonlightwesleyan.org](http://www.sonlightwesleyan.org) or by calling the church at 824-0068.
- Betsy reported that the Senior Expo is scheduled for May 2<sup>nd</sup>. WCSD will have a booth and offer an opportunity for Rx drug disposal.
- Greg reported that the number of drug tests given through probation increased greatly last year. In 2018, 1,100 drug tests were given with that number being down around 300 in recent years. Marijuana use is up, creating a wider margin between that (as most prevalent) and the second most abused drug used by probationers.

- ❖ Brickhouse – Andy said that the store is open and has a special right now for all the taco fixings for \$25
- ❖ Schools are seeing more trends with kids using Juul's with the lower age kids. Juul's are e-cigarettes that are nicotine vaping device. Kids can smoke in the bathroom and flush the toilet and the vape will go down to disguise the vaping. They are seeing it in 6<sup>th</sup> grade and middle school. The chargers look like a flash drive. They are sold at convenience stores and Walmart.
- ❖ Wells County Sheriff's Department has a Facebook page. There were recent arrests for drugs including methamphetamines and cocaine.
- ❖ Adams/Wells Crisis Center – Anita Miller shared that the government shut down has impacted their ability to fund salaries. She stated that they are still submitting grants but due to the delay and new system payments are running 6 months behind. She asked CADA for ideas on how to get community support and funding to fill the gap. Suggestions were made to get in touch with Jessica from the News Banner as well as local radio stations. It was also suggested to contact other shelters in area and Fort Wayne Women's Bureau to see how other agencies are dealing with the funding issues. The Wells Foundation was also given as a resource to reach out to. At least \$60,000 of their funds have been delayed and they could potentially have to close if they can't find options to either get more monies or have a loan for the monies they should have received that are delayed.

## **Member sharing /Community Concerns and Trends:**

- ❖ Jade shared her concerns regarding hypodermic needles being found, on a regular basis, in our community by city workers, police, and citizens. She shared her concerns for community safety, as well as, her compassion for those persons finding themselves deep within the grasps of addiction. She suggested a committee could be established to address this issue within our community. All attendees agreed that a committee was something that should be established. Valerie, Joan, Jade, Kari, Molly, Angie will serve on this committee.
- ❖ Roger Sherer wondered about a panel of folks, including other communities, coming together to talk about what is working in their communities to address this issue. He also suggested vaping and the use of Juules in the schools be discussed.
- ❖ Valarie reported the Resource Center in Fort Wayne could be contacted in regards to how they handle issues with needles in their community. She said they had reached out in the past to Wells County and were met with some resistance. She can provide contact information. Valarie also updated the group that initial assessments are now 2 week out at Park Center and medical assistance treatment (seeing a doctor) are 1-2 days out.
- ❖ Jade shared that Breanna's Hope is going very well. She reported meeting are at Sonlight Wesleyan Church on Monday evenings from 6:30-8:00pm. She reported a meal is served at 6pm. She shared the meetings are attended by folks with addiction issues. They are seeing folks, with issues relating to heroin, methamphetamine, alcohol, and pills. She says the meetings are a place of learning, encouragement, and support. She was pleased to report there is transportation assistance for the meetings and financial assistance for recovery. She said she was especially pleased to share that they received an anonymous donation that will pay for one person's full recovery.
- ❖ Joan shared a bit of her personal story involving her grandson and his journey through heroin addiction. She was able to share that he has been drug free for 2 years. Jade asked if she would be willing to share her story with the Breanna's Hope group and she said she would do that.
- ❖ Pastor Lyle shared information relating to the upcoming Bike-A-Thon that will be held at the Quabache State Park on April 27, 2019. He advised that proceeds from the event will be donated to DARE and Breanna's Hope.
- ❖ John Whicker supported the discussion at the meeting. He said the effects of addiction is a state and community issue and that "it effects all of us."
- ❖ Chuck supported the conversations shared regarding addiction and the effects it has on the individuals using, the families associated with these persons, and the community as a whole. He considered communicating with local groups and educating and educating some more!
- ❖ Jessica shared that the community can drop off unwanted medication/or other drugs, anonymously, at the Sr. Expo on May 2, 2019 at the 4-H building.

They have \$17,000 and are working to reach their goal. Grace of Mercy has also taken some referrals in need. They have gotten oct/nov 2018, but not funding after that. Some new grants have been done, but monies are only available once the shelter is opened again
- Valerie and Deane' attended training around the SMART model focusing on addiction services and partnering in the community. Valerie stated that she can speak in regards to the referral process and what is involved.
- Greg reported that Judge Kiracofe is putting a group together as to Justice Partners Addictions Response Grant \$60,000 is available in this grant. Judge was also noted in the paper as to a case where the sentencing was reduced for the offender based on successful substance abuse treatment.
- Community partners awarded grants to ABLBH and Mentor Moms.
- John – ABLBH is going well, they have a certified Peer Recovery Coach and is attending.
- Roger stated that fund raising is hard as the shelter and inquired about fund raising. They may apply for a gaming license to do a giveaway. The state is behind several months with their payments.

- Molly - Health Advisory Board meeting discussed pressing health needs of Wells County. One of the topics of concern were around vaping and drug issues. The Board will meet again in November
- Deane' – They have two new FCM hires coming in August and September. DCS will be staffed at 14 FCM's and anticipates an additional supervisory position in the future.
- Joan – Shared success story that her family member continues to maintain his sobriety. Joan is also involved in the Indiana Mother's Against Addictions Group. Recovery does happen!
- Lee Golani from Aspen – He works with Medicaid and Medicare grants. They do education through HIP and marketplace. He is at the rescue mission one day a week to assist participants with getting health insurance. He works Adams, Allen and Wells County. He is available to assist with enrollment or education and can be contacted.
- Andy – Andy did some research and looked up syringe charges for previous years: July 2016 to June 2017 9 syringe charges, 2017 – 2018 11 syringe charges and 7 for possession of methamphetamine, 2018 -19 45 syringe charges and 58 charges for methamphetamine. They are not seeing meth labs as this is being shipped from Mexico. Not seeing heroine, but are seeing more methamphetamine as the trend would show.
- Valerie – There is a new peer support recovery group on Sunday "Smart Recovery" and can be found at [www.smartrecovery.org](http://www.smartrecovery.org). They work on different issues as opposed to traditional 12 step programs. The meeting is at Family Centered Services on Sunday at 5pm. This group can be used with faith based models. This is a free meeting and starts this Sunday.
- Park center now has a MAT Suboxone program now. Clients are seen on a weekly or bi-weekly basis by Park Center. There is also a Vivitrol option but this has not been as popular. They are also working closely with probation and jail on having a better transition for clients as they move from incarceration and receive services. Sheriffs are able now to transport county inmates to some appointments. Efforts are focused on getting people enrolled in insurance. There is also a component to have a nurse on staff 24/7 in order to have a MAT program during incarceration as this would be a requirement to provide MAT at the jail.
- Angie Dial – Charles Redwine has reported that Dockside will no longer be offering services in Wells County and their office is closing in September.
- There was a new local coordinators meeting, at which questions were asked: what does LCC look like in your community? , what does substance look like in your community? and how can icji assist in your community?
- Angie will update the meeting resources pamphlet with the new "Smart Recovery" Sunday meeting
- Duck Race tickets are available for FSC's fundraiser.
- ABLBH meet every Monday and they have sent 3 individuals to rehab at this time. 2 have been successful and there has been a total of 7 inquiries into getting assistance with treatment. 18-26 attend the weekly meeting with 1-2 new people each week. They discuss topics and steps. They are always looking for speakers. Topics include, coping skills, triggers and stressors. The CADA grant has been fully utilized by ABLBH. Questions were asked as to the length of inpatient treatment: Detox is 2 weeks, which could be MAT or other, Residential can be from 30-45 days and then to transitional housing where they can stay for up to 18 months. Harbour Lights is one such transitional program utilized.

On 09/11/19 a meeting was held with community partners including ISBH, local Board of Health for Adams & Wells, Bluffton Regional Medical and other community participation. Focus was on educating the health and safety risks around substance abuse. Syringe and non-syringe Harm reduction programs offered through ISCH. Anita from Blackford from BOH, talked about their increase in HIV and infectious diseases associated with an uptick in substance abuse their and their responses and successes/barriers in implementing their harm reduction. Marlene Hoag also sent out questions from other counties with feedback. Per our prosecutor, syringe and methamphetamine charges have continued to rise this year 2019. Jade also surveyed ABLBH with questions relating to substance abuse and shared the information that she collected as to needs in Wells County. The committee would welcome other participants. Marlene was able to get one of each of the kits to look at as well as the list of what is available in the kits. Kits can be modified as to the contents. Discussion about if there is a syringe disposal issue in the community.

Sharps disposal is available at the police station, but there are no others in the community at this point.

## **New Business:**

Grant Screening Review Committee - Molly updated as to the current grant cycle and requests. Applications were due on 8/31/19 and got three applications. Monies were offered in Treatment and Judicial categories. Two of the grants were in treatment, Grace of Mercy, and the second ABLBH toward treatment scholarships. Judicial submitted a proposal from teen court. The committee has recommended funding these. Amounts were divided up between the three to allow for each to receive a portion of the funds. Teen Court was fully funded based on the amount requested.

Motions were made and approved the funding for these grants. These will be on the October council agenda.

BHS - Stacy Morrison BHS presented for Student Drug Testing Grant. They complete 5 tests per week and start after Labor Day and continue through Labor Day. They are utilizing Forensic Fluids for the oral screens. Last year they tested 146 times. 88% had a negative result, 14 tests were positive for nicotine probably juul use, and 1 for suspicion and 1 for marijuana.

BMS - Chris Benedict with Bluffton Middle School, presented for their Student Drug Testing. They complete 2 tests per week during the school year with a total of 72 tests during school.

NHS – Natalie Swinford presented for Norwell High School. They use Forensic Fluids and tested with 15 positive results. The consent for testing was online and they are educating parents more about consenting for the random testing. There is an increase from last year 7 – 8-% in the vaping, 6 were positive on a second offense, which are they addressed with more outreach to the family. They complete 5 per week. Every positive requires a follow up test within a week. If that is negative then there would be another random within 6 months.

NMS – Holly Morgan presented for Norwell Middle School random screens. They also are purchasing through FF and testing 2 students per week. 62 students were tested, 4 positives for amphetamines consistent with the medication prescribed by the students. There were none for nicotine. There are working on making sure that the testing procedure is consistent the procedure at the high school.
