The participants are also connected to many community-based recovery programs and church services. Andrea shared stories from some of the women in recovery at Hannah's House.

Mondays from 6-8 with meal included and childcare is available. 2023 had 237 attendees for the year. Last year gave out 93 blankets and 110 t-shirts, and 50 recovery bibles. Meals and Childcare continue to be high on needs for the meetings as well as a safe place to be.

• ITown Recovery Program - Every quarter they have a group/circle. They are faith based which supports their programs with 12 step components with personal testimony. ### **Resource Presentation:**

- Andy Yergler/Tri Recovery, Inc Promotes endurance sports to work through addictions and recovery issues. He developed his organization from his own experience. Working through addictions with the support of physical activity. They meet weekly on Sundays and go 1 mile of a walk/jog/run at the Pavilion by river greenway at 3pm. After 90 days of weekly attendance participants receive a gift bag and gifts at 1 year of participation and sobriety. The organization supports enjoying a life of sobriety and supports. They have a chapter here in Wells and SW Allen County starting up.
- Wendy Bailey/Alive and Well Community prevention outreach going into schools, public and private to provide information to students. They have educational information about body safety, human trafficking, sexting, mental health, coping skills, substance abuse and other information that can impact youth. They pre-survey youth to determine what topics are pertinent and most needed. They are looking for individuals to present. Programs are provided from 5<sup>th</sup> grade to 12<sup>th</sup> grade. They are working on making video clips with stories to share. They serve Adams &Wells Counties primarily.

### **Grant Program Reports:**

- Angela Hulvey/Norwell HS They received grant money which was used for random drug testing at the high school. They test 5 students a week and it includes students that drive or are in extra-curricular programs. They have a random pull and utilize Forensic Fluids for the testing. They completed 172 tests last year. They had 10 positives for nicotine or THC. The students that are positive do retests several times.
- Kim Conner/Southern Wells Jr/Sr HS They received grant monies also for random drug testing. They test 5 per month grades 7 12. Students who drive or participate in extra-curricular activities. 4 of 46 were positive for nicotine with one for both nicotine/THC. They would like to increase the amount of testing that they are doing.

   Monies were used for items to support completion of activities in their workbook. 10 have successfully completed. They meet Tuesday's at 5pm.
- Stacy Herrold/Chad Griser, BMS Grant monies were utilized to offset costs of random drug screens for student that are involved in sports. They had 8 students tested per month with a total of 80 tests. Increase in positive screens for nicotine and educate for health. 8 of 80 were positive, most likely to vaping. At the high school level, they test sports and extracurricular. They have seen an increase with THC use, most likely edibles.
- Betsy Collier, WOW provides transportation to addiction groups and treatments, ATOD services. \$23 Cost per trip on way and they provided 428 trips. CADA grant monies were utilized to offset these costs.

- Bluffton PD/Det. MJ Heckel Drug Trends
  - 1. THC vapes, some marked, popular brands Chronic & Monameds
  - 2. Meth (methamphetamine) stimulant
  - 3. Fentanyl downer/depressant can go by blue, fake, perk, powder. One pill/2mg cahn be lethal. Naloxone can be used for overdose, but may take several doses and can wear off and need additional doses.
  - 4. Xylazine gives same high as fentanyl and can be mixed with it. It is liquid or wet powder and naloxone will not be effective with overdose
  - 5. The key is education on what drugs do and how they affect your body, ask questions of your kids and keep and eye on their phones and social media/texts.
  - 6. Naloxone is only effective for overdoses with Opiate based drugs like heroine and fentanyl
- Healthier Moms & Babies/Tara Reinhard eligible is less that 29 weeks pregnant/low income and also 1<sup>st</sup> time pregnancy. Once enrolled will be screened for BP, weight, provider connection. Mental Health support and check in. NP can prescribe medication if need. Goal is to provide and help encourage community resources and help moms be self-sufficient to provide care to their children. They continue to provide services up to 6 weeks post-delivery. Teens also qualify for the program.

They services clients with addiction recovery services including med management, psychological support, and individual and group sessions.
