Determination of Quorum:

A quorum was present for the meeting.

Re-Organize Wells County Drainage Board 2025:

Mr. Gerber opened the Drainage Board meeting and turned the floor over to Mr. Hahn to reorganize the Wells County Drainage Board 2025 officers. Mr. Hahn mentioned the nominations are opened for a chairman and vice-chairman, and to reappoint the attorney, engineer and secretary.

Hahn noted the orange highlighted areas are drains that are either at or close to 4 times the annual amount but has plans to use the funds in upcoming projects this year therefore remains to collect. Hahn mentioned the Gregg watershed would like to turn it back on for collection. Hahn mentioned the Dowty and Walters watershed to turn off collection. Hahn also mentioned the yellow highlights are drains that the assessment collections are already turned off and will remain off. Mr. Hahn noted that all other drains not highlighted or mentioned will remain on for collections for 2025.

Mr. Vanover motioned to certify collections of non-highlighted watersheds for 2025, turn on the Gregg watershed for collection, and stop collecting the Dowty and Walters watershed as recommended. Mr. Stringer 2^{nd} . Concurred by Mr. Gerber, motion carried 3-0.
