Trout Moser and Calvin Tims represented the development plan for the new gas station that would replace the existing gas station at the corner SR 1 and Dustman Road. The stormwater plan was reviewed and added area for future road turn lane. The sign design was reviewed as well since a modification would be required due to the sign size. Lighting for the property was discussed with the petitioner and board as well.

Trent Claybaugh presented the development plan for the proposed senior apartments and daycare. He talked about the requirements and layout of the property. The board reviewed the additional items regarding this petition and discussed the city's sign-off. There was mention of the trail and access to the YMCA property. The modification needed was reviewed as the height increase was needed even though it would match the surrounding area. There was no public comment.

Brian Harshbarger presented the plan for the new development. He reviewed the layout of the property and future/overall plan showing detention and buffer areas. Jarrod Hahn talked about items that were concerns during the rezoning process and how they are being taken care of now with the development plan. There was a board discussion on parking, buffers, noise, and stormwater jurisdiction. Geoff Lance thanked them for the detailed notes regarding the landscaping.

Tyson Brooks opened the floor to the public for comment. Susan Grove asked what the building would be used for. Brian Harshberger and Greg Rekeweg explained that it would all be used by Almco. They went on to explain the layout of the building and details of all the use being inside the building. Ron Nelson asked about entrance off Lancaster for this project. It was explained that the plans show a proposed ROW, but it is not currently taking place or would be used for this project at this time. The public comment portion was closed.

Brian Harshberger explained the proposed project in more detail to answer questions from the public. Tyson Brooks said he was overwhelmingly impressed with the design and the work going above and beyond which Melissa Woodworth agreed. There was discussion on the proposed ROW and the timeline of when that would take place. Geoff Lance thanked Almco for addressing issues from the previous rezoning and being a good corporate citizen.
