## **REGULAR SESSION November 4, 2025**

The Wells County Council met in regular session Tuesday, November 4, 2025, at 7PM in the Wells County Carnegie Annex Building, 223 W Washington St., Bluffton, IN. <u>Additional Appropriations:</u> A motion was made by Brandon Harnish, seconded by Steve Huggins to approve the Additional Appropriation request for the General fund for Surveyor and Drainage Board. Motion carried 6-0.
